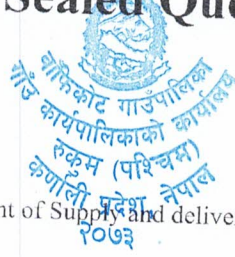

If hard copy is allowed then a complete set of Bidding Documents may be purchased from the office Banphikot Rural Municipality, Rukum Western Rukum Rugha and the office Banphikot Rural Municipality, Rukum Western Rukum Rugha by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs.3000.0 till 29-09-2024 12:00 during office hours.
4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP i.e www.bopatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following account

5. Sealed bids must be submitted to the office Banphikot Rural Municipality, Rukum Western Rukum Rugha by hand or through e-GP system i.e www.bopatra.gov.np/egp on or before 29-09-2024 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 29-09-2024 13:59 at the office of Banphikot Rural Municipality, Rukum Western Rukum Rugha, Lumbini Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 100000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[09403000073] at [Laxmi Sunrise Bank Ltd. Banphikot R M 4 Rukum] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission
