**Invitation for Bids for procurement of Fabricated Steel Parts  
for Pipalbot Trail Bridges**

1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Banphikot Rural Municipality for **Pipalbot Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for **Pipalbot Trail Bridges**. Bid is open to all eligible Nepalese Bidders.
2. The Banphikot Rural Municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum **five trail bridges within last five years**. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLIDAR may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

5. Bidding documents may be purchased from the office of Banphikot Rural Municipality, Western Rukum or **[www.bolpatra.gov.np](http://www.bolpatra.gov.np)** by eligible Bidders, on submission of awritten application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) **09/03/2021AD (25/11/2077BS)**.
6. Bids must be submitted to the office of Banphikot Rural Municipality, Western Rukum or through [www.bolpatra.gov.np](http://www.bolpatra.gov.np), on or before **12:00 noon on 09/03/2021AD (25/11/2077 BS)**. Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at **Banphikot Rural Municipality on 14:00 09/03/2021AD (25/11/2077BS)** at the office of Banphikot Rural Municipality, Western Rukum. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security which shall be **valid for 30 days** beyond the bid validity period.
